# Human Placenta Extract Gel

## **CENTASAVA**

### **COMPOSITION:**

Each gram of Gel contains:

Extract of 0.1 gram of Fresh Human Placenta

Total Nitrogen: Not more than 0.25% w/w

Colour : Brilliant Blue FCF

### **DESCRIPTION**

**CENTASAVA** is a combination of nitrogen and fresh human placental extract. It can be used to treat a wide range of conditions due to its anti-inflammatory and anti-aging properties. It can help improve blood flow, increase hormone levels and speeding up tissue regeneration to promote wound healing with minimal scars.

### **INDICATIONS**

**CENTASAVA** Gel is indicated for the treatment, control, prevention, & improvement of the following diseases, conditions and symptoms:

- Chronic non-healing wounds
- Vitiligo lesions
- Inflammation of placenta

### **DOSAGE AND ADMINISTRATION**

**CENTASAVA** is usually applied topically 3 to 4 times daily or as directed by a doctor. Contact a doctor for the correct dosage and the length of treatment as these depend on the patient's condition and their response to the therapy.

### **DIRECTIONS FOR USE**

- Clean and dry your hands prior to applying the gel.
- Clean the affected area and the surrounding area with water and mild soap thoroughly.
- Spread a thin layer of the medication on the affected areas and apply gently.
- Wash your hands immediately after applying the medication.

### **CONTRAINDICATIONS**

**CENTASAVA** is contraindicated in patients with known hypersensitivity to the active substance or to any of the excipients.

### **SPECIAL WARNINGS AND PRECAUTIONS**

- Before using **CENTASAVA**, inform your doctor about your current list of medications, over the counter products (e.g. vitamins, herbal supplements, etc.), allergies, pre-existing diseases, and current health conditions (e.g. pregnancy, upcoming surgery, etc.).
- Do not take by mouth. Consult with your doctor before using this medicine on open wounds, dry, chapped, irritated or sun-burned skin.

- Wash your hands before and after applying **CENTASAVA**. Clean and dry the skin area to be treated.
- Do not wash the treated area immediately after applying **CENTASAVA**. Also avoid the use of other products on the treated area unless directed by your doctor.
- Applying an excessive amount may result in pilling. Use a thinner layer or lesser quantity of medicine to avoid pilling.
- Avoid getting this medication in your eyes or nose or mouth.

### **ADVERSE EFFECTS**

**CENTASAVA** is a fairly new treatment and may cause unknown side effects. Known side effects include:

- Stinging, burning or irritation at application site
- Difficulty breathing
- Swelling
- Rash or hives

Contact a doctor immediately if side effects persist or worsen.

### **OVER DOSAGE**

- Do not use more than prescribed dose.
- Taking more medication will not improve your symptoms; rather they may cause poisoning or serious side-effects.
- If you suspect that you or anyone else who may have overdosed of **CENTASAVA**, please go to the emergency department of the closest hospital or nursing home.
- Do not give your medicines to other people even if you know that they have the same condition or it seems that they may have similar conditions. This may lead to overdose.
- Please consult your physician or pharmacist or product package for more information.

### **STORAGE**

Store at temperature not exceeding 30°C. Do not freeze.

Keep medicine out of reach of children.

### **SHELF LIFE**

**CENTASAVA** Shelf life is 2 years from the date of manufacturing.

### **PRESENTATION**

**CENTASAVA** is available in 20g in aluminium tube.
